









CALL FOR EXPRESSIONS OF INTEREST FOR THE SELECTION OF YOUNG STUDENTS (MUSICIANS, SINGERS, CONDUCTORS) OF EUROPEAN CONSERVATORIES AND MUSIC INSTITUTES TOBECOME MEMBERS OF THE ERASMUS ORCHESTRA FOR THE TWO-YEAR PERIOD 2023/2025

Art.1 PREMISES AND PURPOSE

In 2017, on the occasion of the celebrations for the 30th anniversary of the Erasmus Programme, the Erasmus+ INDIRE Italian Agency promoted the Erasmus Orchestra project, the first orchestra made up of Erasmus students from Conservatories and/or officially recognized musical institutes in Italy.

As the symbolic value of the Orchestra is considered very important by INDIRE, the project was renewed for several editions at national level. Building up from this success, INDIRE, with the support of the AEC, would like to open it up to Erasmus students all over Europe. The idea is to strengthen the European values through the universal language of music, with young people playing together in harmony.

With this Call for expression of interest, the Erasmus+ INDIRE Italian Agency would like to put together a list of international students who took part in the Erasmus Programme, to be involved in a series of performances to be held between 2023 and 2025.

Art.2 PARTICIPATION REQUIREMENTS

The application must be submitted only by **Higher Music Education Institutions**, **on behalf of their students**. Selected students must respect the following general requirements at the time of submitting the application:

General admission requirements:

- to be enrolled in a Higher Music Education Institution in one of the countries taking part in the Erasmus+ Programme;
- to be a citizen of one or more countries participating in the Erasmus+ Programme;
- to be at least 18 years old.

Each Higher Music Education Institution can propose a maximum of **5 students**, listed in order of preference from 1 to 5 (see the online form) <u>belonging to at least 2 instrument families among the following:</u>





Art.3 SELECTION CRITERIA

The Erasmus+ INDIRE Agency will put together a list of suitable candidates, based on the students proposed by the Higher Music Education Institutions at European level, for the composition of the Erasmus Orchestra, according to the following criteria:

- · completed Erasmus+ mobility for study and/or traineeship (inbound or outgoing);
- technical-artistic mastery: achievement of excellent results in the mastery of at least one of the instruments
 indicated in this document in terms of qualifications and experience as well as in the artistic, theoretical and
 practical preparation, as a singer in the indicated specialties. The respect of this criterium is asked to the Higher
 Music Education Institutions in their selection of candidates;
- type of instrument family indicated, according to the needs of the chosen repertoire.

Art. 4 PARTICIPATION APPLICATION

The application **can only be submitted online** by representatives of Higher Music Education Institutions (staff) by completing the **form** available at the following link https://www.surveymonkey.com/r/ERASMUS ORCHESTRA23-25

The application form must contain complete personal details of the candidates, as indicated.

The application must be submitted within 60 days from the publication date of this call.

Art. 5 DURATION OF THE ASSIGNMENT

The list of candidates proposed by the Institutions and deemed suitable by the Erasmus+ INDIRE Italian Agency will bevalid for the period 2023/2025.

Art. 6 PARTICIPATION IN THE ACTIVITIES

Only students included in the list of selected candidates, will be admitted to participate in the Orchestra's activities. Each eligible candidate will be guaranteed participation in at least one production of the Orchestra in the period 2023/2025. This will be organized according to a rotation scheme, according to the needs of the concert repertoire of the various performances and the level of the students. The evaluation of the candidates will be carried out by the

After the selection phase, the Agency will communicate the details of the performances to the suitable students via email for each performance, in order to define the commitments related to the orchestral rehearsals and their participation in the concerts.

Erasmus+ INDIRE Agency, according to the advice of the artistic director of the project: Maestro Elio Orciuolo.

Participation in the activities of the Erasmus Orchestra is **not paid**. However, a certificate of participation will be issued for each participant.

The selection of suitable candidates for the Orchestra performances will take into consideration the technical requirements of each programme / repertoire and will be the exclusive prerogative of INDIRE, taking into account the advice of the artistic director of the project.



Art.8 TRAVEL. MEAL AND LODGING EXPENSES

The expenses for all the selected eligible students relating to **food and accommodation** for the days of rehearsals preceding the concerts and for the days of the performance, for each production activated in the period 2023/2025, are directly covered by the Erasmus+ INDIRE Italian Agency.

The Erasmus+ INDIRE National Agency reserves the right to cover the **round-trip travel expenses** of the selected students according to the budget available for directly organized /proposed initiatives that foreseen an involvement of the Erasmus Orchestra.

Art. 9 TREATMENT OF PERSONAL DATA

The conservatories, the Institutes and INDIRE undertake to comply with the legislative and regulatory provisions in force regarding privacy, putting in place all the necessary measures to satisfy the security requirements imposed by the aforementioned laws and regulations, processing the data exclusively for the purposes of this selection and operating as independent data controllers.
